Diana Nyad. Very mysteriously, almost identical material to what Poenisch sent

to Jones wound up in Nyad book and in publicity releases for her swims. The Nyad swim (apparently one thins she took was the idea for it) about two months after Poenisch's was promoted by Nyad and Jones as first effort to swim Cuba to U.S., which Poenisch not only had tried but done two months before. Nyad wouldn't make a major swim without bis media present, three times had tried (and failed) Enslish Channel with coverase. Was expert at manipulatins media from childhood on, when a big riece arreared on her in Fort Lauderdale News & Sun Sentinel (which I wrote), story stressed her looks as much as her accomplishments, she was more photomenic than talented at that time. Poenisch won \$5,000 from Swim Hall, \$5,000 from Dick Mullins, \$5,000 from Nyad for libel and slander, plus letters admittins their public statements about him were fabrications. Onsoins series of insults (mention the activity of Mullins at press conference), culminating with scorn at his Cuban attempt (of course, they weren't there, but Mullins went so far as to claim somebody else was in water for him). Poenisch actually spent more than 34 hours in water in Cuban swim, total 34:15. less than 12 minutes (out of allowed 20) out of water for treatment of man 'o war stings. Poenisch had severe left eye problem for year after swim due to lengthy exposure to salt water. He was 65 at that time, now a healthy 77. [QL] rot a

[QL] never met diana nyad to this day, not even in court. was out of court settlement. castro said nothing about her; we didn't see anything about her in cuba. she kert insisting she had visa; it was in newspaper that she had roused the ire of Fidel Castro by callins walter a phony, couldn't set visa, was in newspaper. She wanted to do it before poenisch, we got letter from Washinston, they kept asking him, Rene Mujica, second secretary to the Cuban INterest section in washington, wrote Poemisch to say he was only one with visa, rushed Nyad. She never got visa, started from deserted island near cuba, castro wouldn't let her start from havana. She announced had visa before they even wrote about Walter havins visa. Saw article in Miami Herald, Mujica said didn't know why she was saying that. Then we called Herald and told them Walter had worked 15 years and got his. In JUne was controversy about visas, I swam July 11, she swam late Ausust. She couldn't set visa. said Cubans owe me this. she was 80 miles away from reaching USA (Re95).
